Prof. Pauwelyn has experience « from the bench », as adviser to close to twenty WTO panels and Appellate Body divisions, gathered during six years of service as a legal officer with the WTO Secretariat (1996-2002). In addition, as senior advisor with one of the leading law firms in the field (2007-2014) and, since he left that firm, as independent consultant or president of the TradeLab network of pro bono legal clinics across the globe, Prof. Pauwelyn has experienced WTO and FTA negotiations and trade and investor-state dispute settlement hands-on as independent expert or from the perspective of the parties involved/counsel : diplomatic missions in Geneva, capital-based officials, private companies, law firms and affected civil society actors. His dispute settlement experience ranges from trade remedy disputes (in particular, anti-dumping and CVD cases) and expropriation cases, to highly technical SPS, TBT, GATS and TRIPS cases and more standard GATT and agricultural disputes.
