Born in Amman, Jordan, HE Dr. Tariq Hammouri is the Managing Partner of Hammouri & Partners, Jordan's leading law firm. Dr. Tariq Hammouri took an interest in law at an early age. During his deanship, Dr. Hammouri made major changes to the institution, including setting up the first debate and moot court clubs in Jordan. In addition to his legal practice, Dr. Hammouri served as a legal advisor to the Government of Jordan and assumed a key role in reforming the Jordanian Companies Law as well as the Jordanian Investment Law.

HE Dr. Tariq Hammouri during the period 2018-2020 held the position of the Minister of Industry, Trade and Supply in the Jordanian Government. During that period, Dr. Hammouri, in his ministerial capacity, was involved in the drafting of various laws and Regulations and concluded a number of new international agreements.
