Professor of International Law and European Union Law, Former Director of the Department of Business Studies of the University of *Roma Tre*, in Rome, Italy, where he teaches ‘European Banking and Financial Law’, ‘European Competition Law’, ‘International Law of Economy’ and ‘European Union Law’, Professor Fabio Bassan is Founding Director of the Sovereign Wealth Funds Law Centre.

Prof. Bassan is a well-known scholar and lawyer operating in the Electronic Communications and Copyright markets, as well as in the International Banking and Financial Investment arena. His recent books on this area are: *Digital Platforms and Global Law*, EE Publishing, 2021; *Power of the algorithm and markets' resilience in Italy - The sovereignty lost on services* (Rubbettino, 2019); *Research Handbook on Sovereign Wealth Funds and International Investments Law* (Ed., EE Publishing, 2015); *From Saviour to Guarantor: EU member States' economic intervention during the financial crisis* (Palgrave, 2015); *The Law of Sovereign Wealth funds*, (EE Publishing, 2011).
