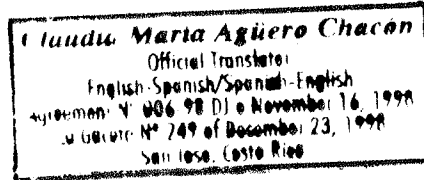

OFFICIAL TRANSLATION
