As stipulated in article 5 of Regulation 1236/2010, Member States shall send a list of their vessels authorised to fish in the regulated Area of NEAFC to the Commission (in computer readable format).  
This information shall be sent no later than December 15 each year or no later than 5 days before the vessel(s) enter(s) the Regulatory Area.

If you already know which vessels will be authorised for 2015 I invite you to send me the lists so I can inform NEAFC.

Please make sure you specify whether the fishery is for regulated resources, deep seas species and/or non-regulated resources.

This needs to be specified for each vessel.

You are of course most welcome to contact me if you have any questions.
