Dear Ms. Norum,

As per our discussion of this morning, Claimants make the following proposal for a joint agreement of the parties in light of Respondent's letter of 5 November 2020 and the Tribunal's direction of 12 November 2020 that Claimants provide any comments on such letter by 19 November:

The parties inform the Tribunal that they have agreed that Respondent will not make public any information currently redacted from the Request for Arbitration until a decision of the Tribunal or an agreement of the parties has been arrived at. The parties have also agreed that they will try to come to an agreement on the issues raised by Respondent in its letter of 5 November, based on the principles established in Procedural Order No. 1, and that, as such, at this time, the Tribunal does not need to decide the questions put forth in Respondent's letter of 5 November 2020. This agreement of the parties is subject to the right of either party, at any time, to seize the Tribunal again of this issue.

As mentioned during the call today, we believe the best time to further discuss this matter would be after the Claimants' Memorial has been submitted on 11 March 2021, when other issues concerning business confidential information may arise and the parties can address these matters based on the principles found in Procedural Order No. 1. We remain available to further discuss at your convenience.
