The objective of NEAFC is to ensure the long-term conservation and optimum utilisation of the fishery resources in its Convention Area, providing sustainable economic, environmental and social benefits.

Welcome to Vessel Masters and their Agents new to NEAFC

In order to operate within the regulations fishing vessels must abide by both the **Current Management Measures** and the **NEAFC Scheme of Control and Enforcement**. The NEAFC Scheme describes the requirements for the reporting of catch and fishing effort and for the monitoring control and surveillance of fishing activities within the NEAFC regulatory area. There are NEAFC provisions (rules) for use of ports of Contracting Parties by fishing vessels with catch on board of fisheries resources that have been caught in the Convention Area by foreign fishing vessels and that have not been previously landed or transhipped at a port which can be found in **Chapter V of Scheme**.

Vessels intending to enter a foreign port with catches on board must notify authorities of their intention in advance (landing, transhipment or other use of ports). To do this it is necessary to have an account on the NEAFC website. Guides to setting up and operating an operating an account to comply with these obligations can be found in the PSC Guides This video guide not completing and submitting a PSC1 form may be useful for new users.

Please note: Creating a web account for EPSC is simple, but it is NOT an instant process. Accounts must be created and then separately activated with the correct permissions by a site administrator. Site administrators work in typical office hours Monday to Friday only.

The North East Atlantic Fisheries Commission (NEAFC) is the Regional Fisheries Management Organisation (RFMO) for the North East Atlantic, one of the most abundant fishing areas in the world.

It is comprised of Contracting Parties which have signed up to the Convention on Multilateral Cooperation in North East Atlantic Fisheries, which entered into force in November 1982. The area covered by the NEAFC Convention stretches from the southern tip of Greenland, east to the Barents Sea, and south to Portugal.

Most of the information on this website is aimed at scientists, control experts, statisticians and managers from the Contracting Parties and other international organisations.

Within the NEAFC regulatory area fishing vessels must abide by both the current management measures and the NEAFC Scheme of Control and Enforcement. Vessels which fail to do so can be considered to be participating in illegal, unregulated or unreported (IUU) fishing.
