1 Name

This is the Fisheries Management (Sedentary Organisms) Proclamation 2015.

2 Commencement

3 Authority

This instrument is made under subsection 12(1) of the *Fisheries Management Act 1991*.

4 Schedules

5 Definitions

In this instrument:

Act means the Fisheries Management Act 1991.

6 Sedentary organisms to which the Act applies—animals

An organism is declared to be a sedentary organism to which the Act applies if the organism belongs to:

- (a) a phylum specified in column 1 of an item of the following table; and
- (b) if one or more sub-categories of the phylum is specified in column 2 of that item—one of the specified sub-categories.
