A private company with a share capital must submit an annual return within 42 days after the anniversary of the incorporation of the company; the other company shall submit an annual return within 42 days after the date of the annual general meeting of the company.

**NOTE:** In order to reinforce supervisory system of combating money laundering and the financing of terrorists in Hong Kong, the companies (Amendment) Ordinance 2018 passed by the Legislative Council of the Hong Kong Special Administrative Region, stipulated that: A company incorporated in Hong Kong to obtain and maintain up-to-date beneficial ownership information, by way of keeping a Significant Controllers Register ("SCR"), for inspection by law enforcement officers upon demand.
