The undersigned, Eng. Rodrigo Hernández Gómez, in my capacity as Deputy Director of Exploitation Services of the Productive State Enterprise Subsidiary of Petróleos Mexicanos, called Pemex Exploration and Production, which I prove with the Resolution CAEPS-PEP-043/2016, issued by the Board of Directors of Pemex Exploration and Production, in its 12th Ordinary Session dated December 12, 2016, where the undersigned was appointed as Deputy Director of Exploitation Services, and in my capacity as Representative of the Productive State Enterprise Subsidiary of Petróleos Mexicanos, called Exploration and Production (**PEP**), which is proved under articles 1, 42, sections I, XXVIII and L, 46 section IX, 122, 123 and First Transitory, Second and Ninth of the Organic Statute of Pemex Exploration and Production published in the Official Gazette of the Federation on January 5, 2017; powers that have not been revoked, modified or limited in any way as of the date of signature of this document.

-----**BACKGROUND**-----

On August 1, 2017, **DRAKE-FINLEY, S. DE R.L. DE C.V., FINLEY RESOURCES, INC. and DRAKE-MESA, S. DE R.L. DE C.V (Joint Participation)** were notified by an official letter number PEP-DG-SSE-679-2017 dated July 31, 2017, whereby **PEP** communicated the commencement of the **CONTRACT** administrative termination proceeding, which purpose is “Integral drilling and completion of land wells in the North and South Region of Pemex Exploration and Production” (Package 5) with a term of execution of 1402 (one thousand four hundred two calendar days) and a minimum approved budget of \$ 418’303,621.55 (Four hundred and eighteen million three hundred three thousand six hundred twenty-one dollars 55/100 USD) not including VAT, communication that was made before Mr. Juan José Jiménez Herrera, Public Notary number 28 in Tampico, Tamaulipas and Ms. María Nora Caballero Verdejo, Public Notary number 4, of the City of Poza Rica de Hidalgo Veracruz.

Within the term granted by PEMEX Exploration and Production to the companies **DRAKE-FINLEY, S. DE R.L. DE C.V., FINLEY RESOURCES, INC. and DRAKE-MESA, S. DE R.L. DE C.V (Joint Participation)**, they submitted a document within the term granted in the official letter PEP-DG-SSE-679-2017, for them to make any statements regarding the commencement of the administrative termination procedure of the **CONTRACT**.

-----RESOLUTION-----

FIRST. - ALLEGATIONS. Pursuant to article 56 of the Federal Administrative Procedure Law, the record formed as a result of the aforementioned administrative termination procedure is made available to **DRAKE-FINLEY, S. DE R.L. DE C.V., FINLEY RESOURCES, INC. and DRAKE-MESA, S. DE R.L. DE C.V (Joint Participation)**, through its legal representative or authorized person, at the facilities of the Gulf Tertiary Oil Contract Residence; part of this Under Directorate of Exploitation Services, located in: Interior Pemex Field, Herradura Neighborhood, Zip Code 933370, Administrative Building of the Northern Region, Poza Rica, de Hidalgo Veracruz (next to the Under Management of Supplies and Administrative Services of Perforation and Project Services, Northern Zone) on business days from Monday to Friday from 8:00 a.m to 8:00 pm, 2:00 p.m and 4:00 p.m to 6:00 p.m, so that, if applicable, they make its **ALLEGATIONS** in the procedure, granting for this purpose a period of **FIVE business DAYS**; counted from the day following the one which it takes effect the notification of this official letter, warned that if it does not do so in the form and within the time limit, its right to exercise it at a later date shall be deemed precluded.---
