



**ELEVENTH DISTRICT COURT IN THE STATE OF

SIGN NOTIFICATION

In the proceedings of the ordinary civil trial 75/2015, of the index of the Eleventh District Court in the State of Veracruz, residing in Poza Rica de Hidalgo, an agreement was issued that literally reads:

Poza Rica de Hidalgo, Veracruz, January seventeen, two thousand and twenty.

Having regard to the foregoing secretarial certification and the procedural status of these records, from which it is noted that there is no original file of ordinary civil trial 75/2015, from the index of this court, from which this incident derives.

The foregoing, by virtue of the fact that by means of official letter 25748/2019, of January 2, two thousand and twenty, it was sent to the Unitary Court of the Seventh Circuit, in turn, with residence in Boca del Río, Veracruz, for the substantiation of the appeal filed by the Defendant Pemex Exploración y Producción, against the order dated December eleventh, two thousand and nineteen, suspending the proceeding in said trial, an appeal that was heard by the Fourth Unitary Court of the Seventh Circuit, residing in Veracruz, Veracruz, filing it with the civil registration number 1/2020, of its index.

By virtue of the above, there is no place to hold the hearing in which the evidence would be received and presented, and the arguments of the parties would be heard, of the incident of nullity of notifications, for which reason it is deferred and postponed, until so re-enter the file. Finally, add the document signed by Raúl López Gallegos, legal representative of the moral plaintiffs and regarding their request that Luis Ángel Gutiérrez Hernández be authorized to carry out and conduct the hearing of the day on their behalf. from today; tell him that there is no place to agree in accordance with the request, since based on article 1 of the Federal Code of Civil Procedures, only the representative or attorney can intervene in the hearing, and not his authorized ones.
