We hereby notify you that based on the communication PEP-SPRN-APA TG-1350-2013 dated August 21, 2013, in which the Administrator of the ATG Production Asset informs you about the suspension of the drilling of wells. It is required to extend the communication and issue the relevant instructions to the service provider companies, in order to do not start the drilling of any more wells and that at the end of the activities of the current well they withdraw their equipment to their respective base or place they have, likewise the companies that did not presented Perforation Equipment such is the case of Compañía Bissell Construcciones e Ingeniería, S.A. de C.V./ MWS Management and due to the delay in the incorporation of the equipments requested in contract 424043804, "Comprehensive Works for Interventions to Land Wells in the Northern Region" (Package I), with the time it has per program (60 days) per well and the expiration date of the contract which is September 30, 2013, it cannot start drilling any well, the drilling program of the wells was as follows:
