**THE RESPONSIBILITY UNIT RULES:**

By virtue of what has been stated by the parties and in accordance with the provisions of Articles 97 second paragraph of the Law of Public Works and Related Services and 289 last paragraph, 291 and 292 section II of its Regulations, the present conciliation is concluded, safeguarding the rights of the parties, so that they may assert them in the instance they deem convenient. Likewise, the powers of attorney exhibited in their initial submission shall be returned to the petitioning companies.

Internal Regulations of the Ministry of Public Administration; First of the Agreement whereby powers are delegated in matters of non-conformities and conciliations, as well as sanctions to bidders, suppliers and contractors, to the public servants indicated, published in the same Official Gazette on July 8, 2015; 95 to 97 of the Law of Public Works and Related Services Law and 284 to 294 of its Regulations; as well as 15, 17-A, 16, 18 and other relative and applicable provisions of the Federal Administrative Procedure Law.

The parties involved in this proceeding are hereby informed that the participation of this Delegation of the Responsibilities Unit of Petróleos Mexicanos Empresa Productiva del Estado in PEMEX Exploración y Producción, Subsidiary of Petróleos Mexicanos, is exclusively of a conciliatory nature, based on the provisions of Articles 95 to 97 of the Law of Public Works and Related Services and 284 to 294 of its Regulations; therefore, the parties are strictly responsible for the agreements reached, as well as any type of statements made in this regard, which will be duly recorded in the case file. However, it reserves the right to carry out any investigation in accordance with the powers conferred by the Law of Petróleos Mexicanos and its Regulations, the Federal Law of Administrative Responsibilities of Public Servants and the Internal Regulations of the Ministry of Public Administration.

There being nothing further to add or record, these minutes are closed at twelve o'clock five minutes past twelve o'clock of the day of their beginning. five minutes past twelve o'clock on the day of its commencement, and the parties sign at the end of the minutes for the record, delivering to each of the parties a simple copy for the record.





